### **A SPECIAL NOTE FOR PARENTS AND LEGAL GUARDIANS:**

Paangea adheres to the U.S. Children's Online Privacy Protection Act of 1998 (“COPPA”) and the guidelines of the Children's Advertising Review Unit (“CARU”) of the Council of Better Business Bureaus, in our Apps directed to children under age 13. Wherever we refer to “children” or a “child” in this Privacy Statement, we mean children under age 13. Please help us protect your children's privacy by instructing them never to provide personal information (like their full name, e-mail address, home address, telephone number, etc.) without your permission.

## A SPECIAL NOTE TO KIDS:

If you are under age 13, you are required to obtain permission from your parent(s) or legal guardian(s) permission before providing personal information, such as e-mail address or phone number, or any other personal information, to Paangea or to anyone else.

## 1. What Are Paangea's Children's Privacy Practices?

Our Apps directed to children under age 13:

- Do not collect personal contact information (like full name, e-mail address, phone number or home address).
- We collect the name of the App and the unique identifier of the device that accesses the App.
- Collected data is used to determine which advertising the (App Host) has served to other apps on your device.
- Data collection is not approved UNTIL parental consent is given.
- We do not ask for more information than is necessary for a child to participate in the activity. We request a user name and a password.
- We take steps to prevent children from posting or publicly disclosing personal contact information, like name, phone number or e-mail address, online, without parental consent.
- We instantly provide parental consent for (dollar amount) USD through online verification by visiting <http://www.paypal.com>.
- We Do NOT disclose collected information to third parties.

### a. What Information Does Paangea Collect from Children under age 13 and How Is It Used?

To access and download our Apps we will ask your child to "register." They can often do so anonymously by just providing a first a user name, and password. When we ask for your child's first name, we encourage them to use a "screen name" (**not their real name**) that only they know, and ask your child to make up a special password. We use technology, like cookies, to recognize visitors by their user name when they revisit our App and to screen for age in accordance with COPPA. We may also use technology for similar purposes in our Apps. Your child cannot download our App and play the game without "registering". Your child cannot register without the consent of a parent or legal guardian.

We also use technology to facilitate the ability to play games, to recognize returning visitors, or to screen under-age visitors from certain features or areas intended for older visitors.

### **b. Can My Child Access the Web Through Your Sites or Apps?**

Apps must typically be downloaded from an app store. Your computer or mobile device may enable you to restrict your child's ability to visit other areas on the Internet and to make purchases online or through Apps.

App stores generally require an adult mobile device owner to register to download or make purchases. Some Apps may offer options to visit an online store to make a product purchase.

We encourage you to spend time with your children when they are online or using any mobile device so you understand the sites, activities and apps they are engaged in, and to adopt available device and browser controls that reflect your preferences about your children's ability to access the Internet or make purchases online.

### **c. Can I Access Update and Review Information You Have About My Child?**

Upon parental consent, a parent or legal guardian can complete the electronic Children's Personal Information Access Request form to review the personal information we will collect or have collected about their child, update their child's contact details, request deletion, or refuse to allow further collection or use of the information.

Please note, however, if you ask us to delete your child's information, your child may not be able to participate in the App activity.
